**SPECIAL TERMS & CONDITIONS**

1. Sealed quotation of rates on per ton / trip basis should be submitted in DUPLICATE as per destination mentioned in Annexure.
2. Tender should be addressed to **General Manager(F&A)/U.H., Burn Standard Co. Ltd, Burnpur works, Burnpur** and submitted on bidder's Letter Head either by Registered Post or in person to Manager (Purchase), Burnpur Works.
3. No tender will be accepted for consideration if it does not reach by the closing time on the due date.
4. The vehicles owned by the bidders and put to services in transportation of goods must possess proper documents and also comply with the provision of the Motor Vehicles Act. 1988 and the Motor Vehicles (Amendment) Act. 1994 with latest amendment, if any.
5. a) Earnest Money of Rs.25,000/- (Rupees Twenty Five thousand only) is to be deposited along with the tender by Bank Draft / Pay Order issued by any nationalized bank drawn in favour of Burn Standard Co. Ltd, payable at Asansol or by cash. Bank Draft / Pay Order or Cash Receipt must be attached with the offer without which no bid will be treated as valid.  
b) Earnest Money Deposit (EMD) of unsuccessful tenders will be returned within reasonable time after finalization of the tender and award of contract to the successful tenderer. The EMD will not earn any interest. EMD of successful tenderer will be returned after receipt of Security Deposit.
6. The company reserves the right to forfeit the EMD of a tenderer in the event of withdrawing his offer before finalization of the tender and award of contract to the successful tenderer.
7. Security Deposit : The successful tender shall, (within 15 working days) after written notice of acceptance of tender has been posted to the tenderer, deposit with the company by Bank draft for a sum of Rs. 50,000/- (Rupees fifty thousand only) drawn in favour of Burn Standard Co. Ltd, payable at Asansol as security deposit.  
a) Alternatively, the successful bidder may furnish approved Banker's Guarantee Bond for Rupees Fifty thousand as per format acceptable to the company towards security deposit.  
b) Security Deposit will not earn any interest.  
c) In case the successful bidder fails to furnish security deposit within the stipulated time limit, the contract awarded may be revoked / cancelled and EMD shall be forfeited.
8. Service Tax on GTA to be incorporated. Quoted value will be reduced to that extent.
9. Rates once quoted shall remain firm for the entire period of contract.
10. Bids shall remain valid for acceptance by the company for a minimum period of 90 (Ninety) days from the due date of bid submission. Any contravention of this condition will make the bidder liable for forfeiture of his EMD.

11. The successful tenderer on being awarded the contract should maintain daily contact with the office of the Commercial Department of BW / BW Cell at Howrah Works for placement of vehicles at short notice.
12. Payment Terms: Terms of payment as 30 days credit must be accepted by the bidders.
13. Loading and unloading will generally be the responsibility of the consignee / consignor. However, rates for manual loading at consignor's end and unloading at consignee's end may be quoted clearly separately in the offer.
14. No detention charge shall be payable to the successful transporter for detention of vehicles due to reasons not attributable to the company.
15. Company reserves the right to accept or reject any or all offers without assigning any reason.
16. Company also reserves the right to recover the full / part value of the goods lost or damaged during transit depending upon merit of each case.
17. Tenderer must furnish trade (Transport) license along with attested Xerox copy of document proving ownership of the vehicles and latest Income Tax Clearance Certificate indicating PAN number without which the offer shall be summarily rejected.
18. This tender will also be subject to our General Conditions of supply / purchase.
19. Period of contract shall be for **one year** . However the period of contract may be extended depending upon the demanding situation.
20. Tenderer must enclose their bid a list of organizations for which they have undertaken or are undertaking transportation job along with performance certificate, in absence of which offer may be rejected.
21. If the transporter refuses or expresses his inability to undertake transportation of material to / from any particular destination, the BSCL Management shall get the transportation done by any available transport and the resultant excess expenditure incurred by BSCL be recovered from transporter refusing / expressing inability to do the same.
22. **Minimum chargeable tonnage shall be 9 M/T for Lorry.**
23. **Order may be split over among the L1, L2 & L3 Bidders. L1 bidder will get 60% of total quantity and rest 40% may be distributed between the, L2 & L3 Bidders proportionately after matching L1 price.**
24. Following information in respect to dimensions of the consignment that can be carried in Lorry must be furnished in your offer.
  - i) Maximum length of goods.
  - ii) Maximum width of goods.
  - iii) Maximum height of goods.
25. As per carriage by Road Rules 2011 notified on 28.02.2011 by Ministry of Road Transport & Highways, Govt. of India, transporters carrying goods should be registered through common carriers only.  
Necessary incorporation may kindly be made and submission of certificate of registration through common carriers to be submitted along with the offer.
